## 月度回顧

日本股市在十月份上漲。

在美國貿易政策和日本政治局勢快速變化的背景下，市場上同時出現了樂觀與悲觀情緒的交織。

因此，投資者將重點集中於與人工智慧（AI）相關的大型股票，導致東證股價指數（TOPIX，含股息）顯著上升，而羅素/野村小型股指數（含股息）僅錄得小幅增長。

我們的基金主要包含小型股，且持有與人工智慧相關的股票較少，因此在 2025 年 10 月表現不如整體市場，出現下跌。

考慮到股票價格的劇烈波動以及投資趨勢的極端偏向，我們認為自四月以來持續的樂觀市場情緒已接近尾聲。

我們相信市場回調的風險正在增加，但一旦調整發生，市場可能會轉向基於公司基本面的選股策略。

小型價值股一直被低估且被市場忽視，與大型股相比，它們在提升股東回報方面具有更大的潛力。

因此，我們認為小型價值股是具有前景的投資標的。

主要貢獻者包括 SOKEN CHEMICAL & ENGINEERING（創研化學）、NIPPON SHARYO LTD（日本車輛製造）以及 AISAN INDUSTRY CORP（愛信工業）。

對於創研化學，並無特定的個別材料，股價自 6 月下旬開始的上漲趨勢持續至今。

對於日本車輛製造，除了對收購要約（TOB）的期待外，市場對亞洲地區鐵路車輛訂單增加的預期也推動了股價上漲。

對於愛信工業，正面因素包括豐田汽車生產的增加、日元貶值的推進，以及對特朗普關稅的擔憂緩解。

主要拖累者包括 TENTIAL INC、RAKSUL INC 和 PROGRIT INC。

對於 TENTIAL INC，下跌趨勢仍在持續。由於電子商務銷售增長停滯及廣告費用增加，經營利潤受到擠壓，導致財務業績低於市場預期。

對於 RAKSUL INC，下跌趨勢也在持續。廣告業務（Nobacel）銷售停滯對其造成影響。

對於 PROGRIT INC，儘管其核心英語輔導服務的增長及新服務的推出使收入和利潤顯著增加，但財報公佈後，投資者獲利了結的拋售壓力蔓延，導致股價下跌。
