## 月度回顧

5 月份，繼上月之後，針對數據中心的積極資本開支繼續受到市場矚目，半導體及電子零部件相關板塊遭遇大幅買入。由於此類股票多為大盤股，東證指數全月上漲+6.23%；相比之下，羅素/野村小盤股指數漲幅略窄，為+5.16%。由於本基金極少持有半導體或電子零部件相關股票，本月基金回報率受到壓制，為-1.11%。此外，小盤價值風格本月也並非市場青睞的投資主線。

我們逢低增持了部分股價下跌、估值更具吸引力且暫被市場忽略的個股。另一方面，鑑於部分板塊因市場結構狹窄而出現急漲，我們對相關個股進行了部分獲利回吐。

近期股票市場波動性進一步加劇。我們預期伊朗局勢難以順利解決，尤其對於前期漲幅過大的個股而言，回調風險正在上升。本基金將堅持恪守價值投資紀律，在控制下行風險的同時，致力於追求長期收益。

#### 主要正向貢獻持倉：

- MIMAKI ENGINEERING CO LTD：公司宣布上調全年業績指引並提高分紅，股價隨之強勁反彈。在工業打印機銷售旺盛以及匯率利好因素的共同推動下，公司連續第四年創下歷史最高利潤紀錄。
- CELSYS INC：在公司公布創紀錄的第一季度業績後，股價急劇飆升。受益於其核心產品「CLIP STUDIO PAINT」訂閱模式的強勁表現以及重大版本更新，公司營業利潤同比激增近 60%。
- NANKAI CHEMICAL CO LTD：公司發布了極為強勁的全年財報，其中新財年營業利潤預測增幅達 35%，並伴隨分紅增加，刺激股價大幅衝高。

#### 主要負向貢獻持倉：

- INTERMESTIC INC： 儘管得益於太陽鏡銷量的穩健增長，公司公布了強勁的第一季度業績並上調了全年利潤預測，但由於前期股價漲幅過大，受獲利盤打壓，股價出現回落。
- TENTIAL INC： 由於獲利盤套現，該股股價出現回調。在上月因業績上調而大幅暴漲後，該股融資盤高企，從而引發了短期拋壓。
- NS GROUP INC： 公司層面並無特定消息面變化。儘管經營業績穩健，但由於該股在前幾個月表現亮眼，引發投資者獲利回吐，導致股價下跌。
